Retrophin, Inc. provides equal employment opportunities for all prospective and current employees. Retrophin, Inc. does not discriminate on the basis of race, color, national origin, religion, gender, gender identity, sexual orientation, age, protected veteran status, disability, genetic information, or any other status protected by law. Retrophin, Inc. takes affirmative action to ensure equal employment opportunity. Affirmative Action is a results-oriented program designed to ensure that each individual can participate equally in all employment opportunities at Retrophin, Inc.
